**Basic Services Of Funeral Director**

**And Staff And Overhead . . . . . \$1,995**

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**Embalming . . . . . \$695**

Except in certain special cases embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

## Direct Cremations . . . \$1,795 to \$10,290

Our charge for a direct cremation (without ceremony) includes:

- Initial transfer of the deceased from place of death to funeral home

- A portion of the basic service charge
- Private family identification viewing – 30 minutes maximum
- Three (3) days of refrigeration
- Local transportation to the crematory (within 25 miles additional charge applies for transportation to an out of town crematory)
- Crematory fee

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of fiberboard and plywood material.

# Survivor Benefits

---

## Social Security Survivors Benefits

You may be eligible for Social Security benefits. You may apply for these benefits by telephone from the comfort of your home. Please call the toll-free number 1-800-772-1213 on a weekday between the hours of 9:00 am and 4:30 pm.

### The Following Is A List Of Survivor Benefits Payable:

#### I. Lump Sum Death Payment (LSDP)

The order of priority in payment is as follows:

- A. The surviving spouse of the deceased who was living in the same household as the deceased at the time of death.
- B. A person entitled to or eligible for widow's, mother's or father's benefits on the deceased's record for the month of death.
- C. A child entitled or eligible for benefits on the deceased's record for the month of death.

#### II. Widow/Widower Benefits

- A. As early as age 50 if completely disabled
- B. As early as age 60 for retirement

#### III. Mother/Father Benefits

- A. Has an entitled child under age 16 in care.

#### IV. Child Benefits

- A. Child of deceased... AND
- B. Under age 18 or under 19 and is still a full-time elementary or secondary school student...OR
- C. Disabled prior to age 22.

#### V. Parent Benefits

When you call, an appointment will be set for a Social Security Representative to call you within a few days. They will request that you have the following information pertaining to the deceased available:

- A. Dates of birth and death
- B. Dates and places of marriages and divorces
- C. Evidence of earnings for the year before and year of death
- D. Social security number for ALL applicants

When the representative calls, he or she will complete an application which will be mailed to you for signature. You should return it by mail with any documents requested. Your documents will be returned to you.
